Report of the Secretary of the Colorado Scientific Society for the year 1886.

Gentlemen :

I herewith respectfully submit a report of the progress of the Society during the past year, and of its condition at the present time,—the beginning of a new year. The statements and figures which I have to submit, together with those from the Museum, show conclusively that the growth of the Society in various directions has been proportionate to the endeavors in those directions. Where



any marked effort has been made there has been a corresponding result, and where apathy prevails there has been little or no gain. Let those members who think that the growth of the Society has been too exclusively in certain directions, remember that they are personally responsible for our development in the lines in which they are personally interested. No offers of aid have been declined; no practical suggestions slighted.

PUBLICATION.

Part I of Volume II of the Society's Proceedings was issued in May. Part II, containing papers of the past year, will be published as soon as possible.

EXCHANGES.

By means of our Proceedings we have come into friendly relations of exchange with a number of foreign and domestic Societies and Institutions. We now receive the publications of 9 State Institutions, and of one private; of 12 Domestic Scientific Societies, and of 10 Foreign. Particular efforts will be made during the coming year to enlarge this list.

THE LIBRARY.

No systematic record of accessions has been kept until within a few months. But few bound volumes have been added. Since June there have been received 12 complete volumes; 45 parts of volumes; 3 pamphlets, and one map. A catalogue of everything now in the library will soon be prepared.

THE MUSEUM ROOM.

In September the Executive Committee secured from the State Historical Society the use of a part of the room occupied by it, situated adjacent to our own, for general The mineral and rock collections museum purposes. were then transferred to the new quarters. Shortly afterward the collections of the Historical Society were removed, and we now have full possession of this room, through the courtesy of the County Commissioners.

CASES.

Since the new room has been secured eight glass cases have been purchased, and in these the mineralogical collection is now being systematically arranged.

THE MUSEUM FUND.

Early in the year an appeal for aid in building up our collections was drawn up by the Executive Committee and printed as the heading to a subscription list. This list was circulated privately, to a limited extent, by a few of the members, and several generous donations were secured. The amount paid in to this Fund in 1886 was \$175.00. The further circulation of this subscription list is most earnestly desired.
