The 2002 program also promises to offer an exciting mix of talks. We have a new program chair, Donna Anderson, who is a research professor at Colorado School of Mines, and previously spent some years in the petroleum industry. Although a new member of the society, she is quite keen (sorry... some language from down under), and I look forward to working with her on the program arrangements. The regularly scheduled meetings of the society are, in my estimation, the backbone of the society activities. With a strong speaker program, we can hopefully increase our membership, and keep our present members coming back for more!

There will be some unusual changes in the schedule in 2002. Ballot to Elect Colorado Scientific Society Officers for the Year 2002

To be elected at our December 6th meeting:



Ballot to Amend Constitution and Bylaws of the Colorado Scientific Society

Please complete and send to the Society at P.O. Box 150495, Lakewood, Colorado 80215-0495 before December 5, 2001, or bring to the November 15th. meeting.

1. The last sentence in Article 1 of the Constitution reads

"The headquarters of the Society shall be located in the City and County of Denver, Colorado." The Society's business address is Lakewood, Jefferson County, Colorado and our meetings and special events are held in Jefferson County (Lakewood and Golden).

The Council unanimously agreed that our location of operation should be updated.

The proposed amendment reads
'The headquarters of the Society shall be located in the County of Jefferson, Colorado.'
I, as a regular or honorary member of the Colorado Scientific Society,
accept () reject ()
the proposed amendment to Article 1 of the Constitution.

2. Article III, Section 3 of the Constitution reads

"The Secretary and the Treasurer shall be appointed by the President, with the approval of the Council."

The Council unanimously agreed that, because the Secretary and Treasurer are voting members of the Council, they should be elected by the Society membership. This amendment, if accepted, would take effect in 2002.

The proposed amendment reads

"The Secretary and the Treasurer shall be elected by the regular and honorary members of the Society. The term of office is one year, but may be extended each year through reelection."

3. Article I, Section 1 of the Bylaws reads

"Application for membership in the Society shall be on a form prescribed by the Council and shall contain a concise statement of the candidate's qualifications and record. Each applicant shall be endorsed by two members in good standing. Remittance for the amount of dues for the current calendar year shall accompany the application..."

The Council recognizes that candidates for membership are no longer required to present qualifications, record, or endorsements.

The proposed amendment reads

"Application for membership in the Society shall be on a form prescribed by the Council. New members shall submit completed application form to the Society. Remittance for the amount of dues for the current calendar year shall accompany the application..."

4. Article I, Section 2 of the Bylaws reads:

"Election to membership shall follow approval of the application for membership by a majority of the Executive Committee and reading the name of the applicant for membership at the first meeting of the Society following receipt of the application. The applicant shall be notified promptly of the decision of the Executive Committee. In case an application is rejected, the accompanying remittance for dues shall be promptly refunded."

The Council recognizes that no Executive Committee has been convened for the purpose of reviewing and approving applications for membership. New members are simply accepted upon submitting application and dues to the Society. The Council recommends that Article I, Section 2 of the Bylaws be removed from the Bylaws.

I, as a regular or honorary member of the Colorado Scientific Society, accept () reject () the removal of Article I, Section 2 from the Bylaws.

5. Article V, Section 1 of the Bylaws reads

"The President shall annually appoint, at least eight weeks before the annual meeting, a committee of at least three members of the society, whose duty it shall be to propose the names of one or more candidates for each elective office of the society. Nominations shall be published in the November newsletter and sent to each regular and honorary member of the Society, with provisions for additional nominations by regular and honorary members at the November meeting. The December newsletter sent to each regular and honorary member of the Society shall include a written ballot containing the names of all nominees."

The Council unanimously agreed that this process of nominating and voting for officers and councilors should be simplified and updated to reflect the procedure currently in use.

The proposed amendment reads

"The President shall annually appoint, at least eight weeks before the annual meeting, a committee of at least three members of the society, whose duty it shall be to propose the names of one or more candidates for each elective office of the society. Nominations shall be published in the November newsletter and sent to each regular and honorary member of the Society. Regular and honorary members may submit additional nominations at the December meeting. Voting will take place at the December meeting."
